# TRANSMISSION TEMPERATURE GAUGE INSTRUCTIONS



The following instructions are for the installation of your Transmission Temperature Gauge into your 3RD Generation Ram Truck. Before you begin, lay out all items and ensure there are no missing parts. If any items are missing, please STOP immediately and contact MaxTow Gauges.

## What's Included

- Transmission Temperature Gauge
- 1/8-27 NPT Transmission Temperature Sensor
- Power & Sensor Harnesses
- Mounting Bracket
- Gauge Visor

# Black: Vehicle/Engine Ground (-)

Yellow: 12v Constant Source (+)

Red: 12v Ignition Switched Source (+)

**Drange:** 12v Headlight Switched Source (+)

#### **AWARNING** DISCONNECT NEGATIVE BATTERY TERMINALS BEFORE STARTING ANY WORK ON THE VEHICLE.

Check that you have all parts required for installation, and that the engine is cool.

1. Open the hood and locate the truck's batteries. Using a wrench, disconnect the negative terminal of each battery to ensure there is no power running through the truck during the installation.

**Nate:** When it comes time to wire and connect the gauge to its power source, you will be able to reconnect the negative terminals on the batteries.

*Warning:* Be sure that the transmission is cool before removing the transmission cooler line.

- The transmission temperature gauge can be installed in one of two ways: using a transmission test port extender adapter or by using a 1/2" transmission line T-fitting adapter.
- **3.** On 03-07.5 48RE Transmissions either a Test Port Extender or Transmission T-Fitting adapter can be used. On 07.5-09 68RFE Transmissions ONLY a Transmission T-Fitting can be used.

## Transmission Test Port Extender Installation:

 Safely jack up the truck, if not raised already. Locate the middle test port plug on the passenger side of the transmission case. Using an 11mm Wrench, remove the test port plug.

**Nate:** Have a drain pan available for any fluid that will leak from the fitting.



- 2. Wrap Teflon Tape on the male threads of the sensor and test port extender adapter. Thread the sensor into the test port extender adapter and tighten using a 17mm Wrench and 14mm Wrench.
- **3.** Thread the test port extender with the sensor attached into the transmission test port and tighten using a 17mm Wrench.

### 1/2" Transmission Line T-Fitting Adapter Installation:

**Wire Schematic** 

 Safely jack up the truck, if not raised already. Using a 15/16" Wrench, hold the brass fitting on the transmission and use a 3/4" Wrench to unscrew the line fitting.

Note: Have a drain pan available for any fluid that will leak.

- 2. Remove the retaining bracket using a Flat Head Screwdriver. Unscrew and remove the line from the torque converter cooler using a 7/8" Wrench.
- **3.** Using a Marker, mark the cooler line where you will cut to remove approximately 1-7/8" of the line. Use the Pipe Cutter to cut the line where you have made your marks and then deburr the cut ends. Insert the nut and cutting ring onto the line where you have just made your cut and repeat on the other side.



- **4.** Install the cooler line T-fitting female compression nuts over each end of the cut line. Then place the metal cutting rings over each end of the cooler line.
- Hold the body of the T-fitting with a wrench and hand tighten each compression nut. Then tighten 1-1/4 more turns with a 7/8" Wrench to ensure proper sealing of the cutting rings.
- **6**. Now you can install the 1/8-27 NPT temperature sensor into the port on the T-fitting housing.

**Nate:** Be sure to use Teflon Tape on the threads of the temperature sensor to prevent any leaks.

7. Reinstall the cooler line with the T-fitting adapter attached and refill the transmission with up to 4 quarts of proper grade transmission fluid.

**Nate:** Check the dipstick to ensure the proper amount of fluid is in the transmission.

## Wiring the Transmission Temperature Gauge:

- 1. Plug in the Transmission Temperature Sensor Harness to the Temperature Sensor.
- 2. Route the Transmission Temperature Sensor Harness up to the firewall to the driver side of the engine bay and use Zip Ties to secure the sensor wires. Ensure there is no contact with any direct heat source or moving parts.

Note: Required on 07.5-09 68RFE Transmissions

# Factory Matched 3RD Gen Gauge Wiring

Reconnect the negative terminals of the two batteries to prepare power for the gauges and to test the fuses for power with a Test Light.

1. Run the power wires through the firewall and into the engine bay of the truck.

**Nate:** You may need to drill a hole in the firewall if there isn't one present. It is important to use a Grommet on the hole to ensure the wires are not sliced or cut on the firewall.

2. Drill a hole in the side of the fuse box located under the hood in order to run the wires inside without them being pinched on the fuse box lid. Be careful not to damage anything while drilling.

**Nate:** Steps 3, 4, and 5 are based on a 2009 vehicle. Please refer to the chart below for the fuse locations for your specific vehicle. Be sure that two fuses are installed in each Expandable Circuit.

- **3.** Locate and remove fuse #31 POWERTRAIN CONTROL MODULE (10A) from the fuse panel. Using the Expandable Circuit, crimp the yellow wires to the Expandable Circuit and insert the circuit into the empty fuse #31 slot.
- Locate and remove fuse #33 HEATING AND A/C (10A) from the fuse panel. Using the Expandable Circuit, crimp the red wires to the Expandable Circuit and insert the circuit into the empty fuse #33 slot.
- 5. Locate and remove fuse #16 RIGHT FRONT PARKING / TURN LAMP (15A) from the fuse panel. Using MaxTow's Expandable Circuit (Optional), crimp the orange wires to the Expandable Circuit and insert the circuit into the empty fuse #16 slot.
- **5.** Connect the black wire to any bare metal grounding location. If the black wire is not connected to a bare metal grounding location the gauges will not power on. Tip: Remove all rust and paint from the grounding location for a better connection.
- 7. Secure any excess wiring with Zip Ties.
- **B.** Reinstall the dash side cover and any interior trim that was removed. Check and fill the Transmission Fluid according to manufacturer specifications.
- **9.** Power the truck on to see if the gauges are functioning properly and check for any leaks or loose sensor connections.
- Test drive your vehicle to ensure all gauges are functioning properly.

## Selectable Brightness Levels

The Double Vision Gauge Series features 3 selectable brightness settings for both day and nighttime lighting modes. Below are the instructions on how to program each lighting mode.

#### Daytime

- Press and hold the button located on the gauge face until a "d1" appears in the digital display.
- Press the button again to cycle through the 3 dimming modes.
- Press the button until you have selected your desired setting. Do not touch the button for 5 seconds and the gauge will save your selection.

#### Nighttime

- This mode is only available if the orange dimmer wire is connected and your headlights are powered.
- Press and hold the button located on the gauge face until an "n1" appears in the digital display.
- Press the button again to cycle through the 3 dimming modes.
- Press the button until you have selected your desired setting. Do not touch the button for 5 seconds and the gauge will save your selection.

## **Universal Gauge Wiring**

 Using a test light, locate a constant 12-Volt Power Source in the vehicle's fuse panel that receives 12-Volt Power when the ignition is turned off. You can splice into the circuit or use an optional Expandable Circuit. Connect the **Yellow Wire** of the gauge to the Constant 12-Volt Power Source.


**Nate:** It is required to use an automotive grade 18-20 gauge wire and proper splice connectors when extending any of the power wires.

- Repeat the same step for the *Red Wire* of the gauge to locate an Ignition Switched 12-Volt Power Source. This source should not have any power with the key turned off and have 12-Volts with the key turned on.
- 3. Connect the **Drange Wire** of the gauge to the positive Headlight Switch Power Source using a Splice Connector at the headlight switch. You can also use an Expandable Circuit and install into the fuse box if you have a fuse available. This will allow the gauge face to dim 30% when the headlights are turned on.

**Nate:** Make sure that the connection source does not dim. If the voltage is reduced when you lower the Dimmer Wheel it will cause the gauge to flash from not having enough voltage.

 Locate a clean, reliable grounding source and connect the *Black Wire* from the gauge.

# **Additional Information**



The supplied optional gauge visor is intended to be placed on the gauge so that the thickest part is at the top, creating a cover over the gauge to help keep sun glare off of the gauge face.

The included mounting bracket is designed to be used on a universal-style mount in order to keep the gauge secure. In some cases one or both legs of the bracket may need to be modified to fit the thickness and contour of the mount. Our A-pillar gauge pods do not require the use of the mounting bracket but can be used if you desire, and there is enough space to fit it between the gauge and the gauge pod. When installing the bracket onto the gauge, make sure not to over-tighten as it could pull the rear studs on the back of the gauge and damage it.

#### **ONE YEAR NON-TRANSFERRABLE LIMITED WARRANTY & DISCLAIMER**

MaxTow Gauges, LLC ("MaxTow") warrants to the original retail consumer purchaser, and not any other purchaser or subsequent owner, that this Product will be free from defects in material or workmanship for a period of **one (1) year** from the purchase date.

For a period of **one (1) year** from the date of purchase, at no charge to the Purchaser, MaxTow will repair or replace this Product if it is determined by MaxTow to be defective. After the warranty period, the Purchaser must pay all charges for parts and labor.

Coverage under this warranty is only valid within the United States, including its territories, as well as in certain other countries. Purchasers should check our website, **www.MaxTow.com**, to determine the warranty coverage in the countries in which they are located.

MaxTow does **not warrant the installation** of the Product, which is the sole responsibility of the Purchaser. Installation should be done by licensed professionals. Improper installation may cause damage to the Product and any vehicle in which it is installed, and may cause burns and electrical injury to individuals. MaxTow's warranty does not cover any expenses incurred in removing Products that are defective or reinstalling replacement Products in their place.

During the warranty period, to have the Product repaired or replaced, the Purchaser must return the Product, freight prepaid by the Purchaser, to MaxTow (but for customers in the contiguous United States, MaxTow will pay the shipping charges if any Product fails during the first thirty (30) days after purchase). The Product must be returned in its original carton or in a similar package affording an equal degree of protection. MaxTow will return the repaired or replaced Product, freight prepaid, to the Purchaser. MaxTow does not provide Purchasers with temporary replacement units during the warranty period or at any other time.

This limited warranty is nontransferrable and will automatically terminate if the original retail consumer purchaser resells the Product or transfers the vehicle in which the Product is installed. An "original retail consumer purchaser" is a person who originally purchases the Product, or a gift recipient of a new Product that is in its original packaging and unopened.

This limited warranty is subject to all of the following terms and conditions:

#### **TERMS & CONDITIONS**

1. NOTIFICATION OF CLAIMS; WARRANTY SERVICE: If Purchaser believes that a Product is defective in material or workmanship, written notice with an explanation of the claim shall be given promptly by Purchaser to MaxTow. All warranty claims must be made within the warranty period, and any Products returned to MaxTow must be shipped in accordance with MaxTow's procedures (including use of RMA numbers supplied by MaxTow after notification). The repair or replacement of any Product or part thereof shall not extend the original warranty period. The specific warranty on the repaired part only (not including gauge sensors) shall be in effect for a period of ninety (90) days following the repair or replacement of that part, or the remaining period of the Product warranty, whichever is greater. MaxTow does not provide a warranty on replacement gauge sensors.

2. **EXCLUSIVE REMEDY; ACCEPTANCE:** Purchaser's exclusive remedy and MaxTow's sole obligation is to supply (or pay for) all labor necessary to repair any Product found to be defective within the repair or replacement fails to remedy the defect. Purchaser's failure to make a claim as provided in paragraph 1 above or continued use of the Product shall constitute an unqualified acceptance of such Product and a waiver by Purchaser of all claims thereto.

3. **EXCEPTIONS TO LIMITED WARRANTY:** MaxTow shall have no obligation to Purchaser with respect to any Product that is subjected to any of the following: abuse, improper use, negligence, accident, modification, failure to follow the operating procedures outlined in the user's manual, failure to follow the maintenance procedures in the service manual for the Product, attempted repair by nonqualified personnel, operation of the Product outside of the published environmental and electrical parameters, or if the Product's original identification (trademark, serial number) markings have been defaced, altered, or removed. MaxTow excludes from warranty coverage Products sold AS IS and/or WITH ALL FAULTS. MaxTow also excludes from warranty coverage any consumable items such as fuses and batteries.

All software and accompanying documentation furnished with, or as part of the Product is furnished "AS IS" (i.e., without any warranty of any kind), except where expressly provided otherwise in any documentation or license agreement furnished with the Product.

4. **PROOF OF PURCHASE; REGISTRATION:** The Purchaser's dated bill of sale must be retained as evidence of the date of purchase and to establish warranty eligibility. Registration of any Product or of this limited warranty is voluntary, and failure to register will not diminish any rights available under this warranty.

#### **DISCLAIMER OF WARRANTY**
